Plain English explanation

NHS North East London (NEL) holds and uses limited patient data for the purposes of Complaints, Subject Access Requests and Freedom of Information Requests.

We collect and store information that has been received directly from you or other organisations

Under GDPR and the Data Protection Act 2018, you have the right to see or be given a copy of any personal data held about you by NEL. To gain access to a copy of your information, you will need to make a Subject Access Request (SAR) to the CCG.
