Executive summary	Following the July RPbP board approval of the proposed Health Inequalities (HI) funding bids there were some further amendments made to the final submissions which were as follows:
	 Inclusion of a 'Wellbeing Hub' bid from the Black women's kindness initiative that was submitted but not received or evaluated in the original process. The bid was evaluated via the same process at the HI Steering group and the £2.6k request was approved Removal of the CVD Health promotion bid for £45k due to duplications on the delivery of the NHS Confederation bid.
	This left the total for the 23/24 bids at £613k.
	Places were informed in July by NEL NHS finance that funding would be provided for three years from start of delivery, rather than aligning with financial years. The assumption is that delivery begins in Autumn 2023, therefore 8 months of funding would be provided in FY 2023/24 and the remaining 4 months of funding moved to the end of the three year programme in 2026/27 (to cover April-July 2026). As such the Year 1 allocation for Redbridge was £504,666 rather than £757k as originally profiled. This meant that there was no longer any contingency funding as previously reported and there was in fact an overspend of £108k.
	As a work around it was agreed that £108k of the £119k that LBR was due to receive via Sec 256 funding for HI projects (Accessible information standards, HFCA and Exercise on referral) would be held back and paid in a subsequent year. This enabled all the approved bids to continue as planned. LBR would use alternative funding streams, including Borough Development money to meet the shortfall.
	The bids that are not being funded by a section 256 agreements were submitted and approved at the NEL procurement group on the 18 th August 2023. This equated to 14 schemes totalling £493,704. Subject to final sign off by the Chief Financial Officer (slightly delayed due to a further review of all procurement

schemes) payment should be received by these organisations in Oct 2023. Once the final financial governance for the dispersal of the funding is completed the RPbP PMO team will be contacting each of the organisation to discuss monitoring arrangements. The HI steering group is proposing the following: PMO team will meet and discuss qualitative and quantitive measures for each project with the relevant project leads, these will be proportionate to the size of the project and the funding allocation, based on the original application Each organisation will report monthly on project progress to the PMO team Quarterly reports will be submitted to the HI steering group, with an emphasis on exception reporting where projects are not delivering or are off track with the Hi Steering Group providing a supportive approach to help to get schemes back on track The HI Steering group is proposing that any commitment to further years funding be decided in April 2024, following 2 quarters of monitoring, with the exception of the RedbridgeCVS Healthy Communities team. The team of 7 part time officers have been in post since January 2023 delivering Health engagement and promotion across the borough, funded by HI. The current funding runs out at the end of March 2024 and to ensure continuity of the service RCVS need confirmation of 24/25 funding to retain staff. The bid has already been evaluated and approved by the HI steering group.
