NHS North East London (NEL) keeps personal and confidential information about you (Your clinical and Social Care records) relating to Continuing Health Care (CHC), NHS Funded Nursing Care (FNC), Individual Funding Request and Personal Health Budget services where you have applied for these services.

This data is used to assess whether you meet the criteria for funding for these services and to enable provision of services thereafter. Data may also be used for audit and monitoring purposes for service improvement.

People who have access to your information will only normally have access to that which they need to fulfil their roles.

You have the right to object to our sharing your data in these circumstances, but we have an overriding responsibility to comply with our legal obligations. Please see below.

We are required by Article 13 in the General Data Protection Regulation to provide you with the information in the following 9 subsections.

3) Purpose of the processing	Direct Care is care delivered to the individual alone. After a patient agrees to a referral for direct care elsewhere, such as a referral to a specialist in a hospital, necessary and relevant information about the patient, their circumstances and their problem will need to be shared with the other health and social care workers, such as specialist, therapists, technicians etc. The information that is shared is to enable the other health and social care workers to provide the most appropriate advice, investigations, treatments, therapies and or care. In order to receive NHS CHC and FNC funding individuals have to be assessed by NEL according to a legally prescribed decision-making process to determine whether the individual has a 'primary health need'.

* "Common Law Duty of Confidentiality", common law is not written out in one document like an Act of Parliament. It is a form of law based on previous court cases decided by judges; hence, it is also referred to as 'judge-made' or case law. The law is applied by reference to those previous cases, so common law is also said to be based on precedent.

The general position is that if information is given in circumstances where it is expected that a duty of confidence applies, that information cannot normally be disclosed without the information provider's consent.

In practice, this means that all patient information, whether held on paper, computer, visually or audio recorded, or held in the memory of the professional, must not normally be disclosed without the consent of the patient. It is irrelevant how old the patient is or what the state of their mental health is; the duty still applies.

Three circumstances making disclosure of confidential information lawful are:

- where the individual to whom the information relates has consented.
- where disclosure is in the public interest; and
- where there is a legal duty to do so, for example a court order.
